### **PRIVACY POLICY**

This Privacy Policy describes how CRANIOCATCH MEDİKAL VE DENTAL BİLİŞİM TEKNOLOJİLERİ ANONİM ŞİRKETİ / CRANIOCATCH MEDICAL and DENTAL INFORMATION TECHNOLOGIES INC. (may be referred to as "we", "us", "Company" or "Craniocatch Inc.") collects, uses, transfers and protects personal data in connection with www.craniocatch.com ("website") and also with Craniocatch Software.

### INFORMATION WE COLLECT

**Customer Information:** If you sign in to website or requested demo use or send us an email, we collect the information about your credentials (name, surname, identity number), contact information (phone number, e-mail address, permanent address), employee information (the name of the company you work, tax identification number)

*IP and Log Information:* If you visit our website, we may collect electronic data processing security information such as IP address of all visitors, whether they are customer or not, and log file information. Log file information is automatically reported by your browser each time you access a web page. Log files may include, browser type, number of clicks, domain names, pages viewed, URL's and other such information. If you access our services through mobile devices, we may collect the unique ID and the IP address of your mobile device and also some other device identifiers such as operating system, Internet browser.

Cookies and Web Beacons: When you visit the website, we may send cookies which are a small text file. Some of the cookies does not collect personal information about you. You can read our cookie policy and you can refuse the cookies which are not obligatory. But some of the features of Website may not function properly if you decline the use some cookies. Some parts of our Service and the emails we send may include tiny electronic elements called web beacons. These elements allow the Company to do things like tally the number of users who have viewed specific pages or accessed an email. They also help us gather website statistics, such as measuring the popularity of particular sections and ensuring the integrity of our systems and servers. Your personal data is processed via the website (portal), e-mail, digital forms and other computer technologies, according to the legal reasons stated above.

# TRANSFER OF PERSONAL DATA

Your Personal Data shall be transferred by Craniocatch Inc to its business partners, lawyers and competent courts and/or enforcement offices and public institutions and organizations for the purpose of legal and financial audits in Turkey in accordance with the General Principles of GDPR and KVKK.

Personal data may be shared with third parties with the explicit consent of users. Craniocatch Inc. takes all the necessary technical and administrative measures in case your personal data is transferred to home or abroad. In addition, a commitment is taken from the third parties who transfer data to ensure that they take the necessary technical and administrative measures.

## **RIGHTS OF DATA SUBJECT**

Data subjects have the following rights:

- Information and access to personal data,
- Rectification and erasure ('right to be forgotten',
- Right to data portability,
- Right to object and automated individual decision-making,
- to request the rectification of the incomplete or inaccurate data, if any,
- Right to stop or limit processing of personal data,
- and the other rights regulated in GDPR and KVKK.

## **CHILDREN'S PRIVACY**
